DEFINITIVE MAP MODIFICATION ORDER 2022**

OF: 3 Cotton Tree Barn, Second Terrace, Sunderland Point, Morecambe, LA 3 3 HT

The above Order, made on the 18th May 2022, if confirmed as made, will modify the Definitive Map and Statement of Public Rights of Way for the area, by recording a restricted byway known as Moss Lane from Downeyfield Road immediately to the east of Downeyfield Bridge in a generally south south easterly direction to Middleton Road immediately east of Middlepool Bridge.

The length of the route is 0.88km and the width varies between 5 metres and 12 metres.

If no representations or objections are duly made to the Order, or if any so made are withdrawn, Lancashire County Council, instead of submitting the Order to the Secretary of State for the Environment, may itself confirm the Order. If the Order is submitted to the Secretary of State for the Environment, any representations or objections which have been duly made and not withdrawn will be sent with it.
